As a trainer*, I confirm that I:

comply with the rules of trotting sport and competitions, including guidelines, directives and decisions adopted on their basis and in accordance therewith, and agree, inter alia, to:

- the Competition Regulations of the Estonian Trotting Association (hereinafter ETA);
- the ETA Anti-Doping Regulations;
- the ETA list of prohibited substances and medication withdrawal periods;
- the use of the ETA treatment log;
- the ETA Disciplinary Regulations;
- the communication standards for drivers, trainers and judges of the Estonian Trotting Association;
- applicable trotting sport rules adopted by international sports organisations or nationally.

I have familiarised myself with competition guidelines, participant status and rules for participation in trotting sport, as well as other documents regulating trotting sport approved by the ETA Board or other bodies, and undertake to comply with them;

I have familiarised myself with ETA competition guidelines and undertake to comply with them;

I am aware of the prohibition of the use of prohibited substances and methods set out in the ETA Anti-Doping Regulations and undertake to comply with them, including consenting to doping controls, providing doping samples and allowing doping samples to be taken from horses under my responsibility;

I undertake to follow the ethical principles of trotting sport set out in the following Code of Ethics:

I undertake to adhere to the principles of loyalty, honesty and sportsmanship in accordance with the Fair Play principle;

I recognise applicable trotting sport rules adopted by international sports organisations or nationally;

I refrain from any conduct that damages or may damage the integrity of trotting competitions organised by the Estonian Trotting Association or other trotting sport organisations and undertake full cooperation with the Estonian Trotting Association and other competent bodies in combating such conduct in accordance with applicable rules.

DATA PROTECTION NOTICES

I acknowledge that the ETA and competition organisers, taking into account the specific nature of trotting sport, have the right to collect, process and publish trainer, driver and horse results achieved at competitions included in the ETA competition calendar for the purposes of developing and supporting trotting sport and preserving sports history;

I acknowledge that my name, date of birth, citizenship, image and data related to my sporting activities may be published on the websites of the Estonian Trotting Association and/or the Hippodrome;

I acknowledge that the ETA and competition organisers have the right to record audio and visual material at events related to me (including competitions);

I acknowledge that the Estonian Trotting Association and competition organisers have the right, free of charge and for non-commercial purposes related to the development, promotion and coverage of trotting sport, to use and authorise third parties to use photographs and audiovisual materials created of me together with my name and related data.

ARBITRATION AGREEMENT

The trainer and the Estonian Trotting Association agree that all domestic disputes related to trotting sport arising from or in connection with the Statutes of the Estonian Trotting Association or other ETA documents shall be resolved in accordance with the dispute resolution procedures set out therein, including that:

a) decisions of the ETA Board adopted pursuant to clauses 7.6 and 7.7, clauses 10.1–10.6 and clauses 12.2 and 12.3 may not be appealed;

b) decisions adopted pursuant to clauses 11.1–11.6 may be appealed to an independent Appeals Committee;

c) a written appeal must be submitted to apellatsioon@hipodroom.ee within 14 days from the date on which the recipient is deemed to have become aware of the decision. The Appeals Committee is an independent three-member body appointed by the Board of the Estonian Anti-Doping and Sports Ethics Foundation (EADSE). Upon receipt of the appeal, it shall be forwarded to the EADSE Board for the formation of the Appeals Committee;

d) the decision of the Appeals Committee is final.

In domestic disputes for which no internal dispute resolution procedure exists within the

Estonian Trotting Association, as well as in disputes for which the ETA lacks competence, neither the trainer nor the Estonian Trotting Association shall turn to state courts. The dispute shall be submitted exclusively to an independent and impartial Sports Arbitration Court established under Estonian law and operating in Estonia, recognising its arbitration rules and its decision as final and binding.

I expressly acknowledge and agree that if a decision establishing a violation of anti-doping rules is made and enters into force in respect of me, the Estonian Trotting Association and/or competition organisers have the right to publish such decision and the imposed sanction (including the nature of the violation, the type and duration of the sanction) on the official websites of the Estonian Trotting Association and/or the Hippodrome.

The licence is valid until 31.12.2026.
